Introduction to the Wasp Weapon

A "less-lethal" response as it relates to the WASP Weapon means that the WASP Weapon will inflict less physical damage and a lower incidence of fatal injury than a 9 mm bullet fired from the same gun and striking the same person in the same location on their body. A "less-lethal" response does NOT necessarily mean a "non-lethal" response.

The WASP is designed to be used only in life & death situations where you would use a firearm. The WASP provides a less-lethal option to resolve life or death conflicts.

The WASP equipped firearm provides an added option to the user's over a standard firearm without reducing the user's overall security.

The WASP Weapon is a firearm accessory that converts your pistol into a dual-use weapon, offering the user a less-lethal option in addition to their fully functional firearm.

The user can fire a WASP baton and then immediately use the same firearm to fire a 9 mm bullet. No modification or additional action is required.

What You Need in Addition to the WASP

The WASP is a firearm accessory that attaches to a semiautomatic handgun. You will need:

- 1) A modern 9 mm semi-automatic handgun in good working condition.
- 2) Threaded Barrel with 1/2" x 28 threads, designed for your handgun.

The threaded barrel is used to attach the WASP Launch Barrel.

See your firearms dealer to acquire the proper barrel. These are the same barrels one would use with silencers, flash suppressors or compensators.

Threaded Barrels are available for most popular handguns, either through the manufacture or a good quality after-market manufacture.

Setting Up Your Pistol With The WASP


Detailed working knowledge of firearm use and safety protocols is required before operation of the WASP System.

Always make sure the firearm is UNLOADED. Remove the magazine, and visibly check the chamber to make sure no bullet is present.

Always keep the firearm muzzle pointed in a safe direction. Never place your hand or any part of your body in front of the barrel.

Below is a comparison between a standard Glock 19 barrel and a threaded Lone Wolf Glock 19 after market barrel.

Your pistol needs to be equipped with a threaded barrel to use the Wasp Weapon .

Setting up continued

After the firearm is clear of any ammunition, attach the barrel adaptor to the firearm by screwing it onto the treads in a clockwise direction.



Barrel adaptor installed on a Glock 19 (empty of ammunition, breach open, magazine removed)



Loading

With the gun unloaded, you can now mount the Baton.



Grasp the baton as you would pick up a glass, avoid grasping the end; as that would place your hand in front of the barrel and in the line of fire in the event of an accidental discharge.

Slide the baton down the barrel adaptor as far it can go.




Loading continued

Load your pistol's magazine as you would normally (standard 9 mm ammunition), with the following exceptions:

The Blue (practice) Baton may be launched with 9 mm blank rounds. This makes it 'semi-reusable' for training and practice purposes only.



The Black Baton is only for self defense use, and can only be fired once.



Batons may only fired with a bullet once.


Targeting and Firing

If you ever find yourself in a self-defense situation, where you have to defend yourself or family.

Wasp has an effective range of 25 feet.

Target the attacker's center-body mass...and fire.

You can slide a second Wasp Baton on the Barrel Adaptor or if needed, the firearm is ready to fire live bullets





BE SMART

If you wouldn't shoot it with a standard gun, don't shoot it with a gun equipped with a Wasp Equipped Firearm.
